Harvey motioned to approve the consent agenda, seconded by Reeves. All ayes.

Mayor Speckner opened the public hearing for approving the application for annexation for the new development. Vogt motioned to close the Public Hearing, seconded by Reeves. All ayes.

Travis motioned to approve Resolution #2023-06-05, Approving Applications for Voluntary Annexation. Harvey seconded. All ayes.

Scott Musgrove shared drainage concerns from the new development and how the immediate properties will be affected. We are still on the preliminary plat and these items are being discussed. Tom Greenwood had questions on the annexation. Vogt to discuss with Greg about a fence by Musgrove's.

The preliminary plat was given to the council for review and discussion at the 6-20-2023 meeting.

Community endowment fund information was given to the council for a possible tax planning or inheritance tool.

Thorkildson motioned to approve Resolution #2023-06-05B, PCI pay estimate #4 Sells Street Bridge Project. Travis seconded. All ayes.

AppRiver emails were discussed. Vogt, Harvey, Thorkildson, and Speckner to be taken off.

Vogt motioned to approve Shellsburg Quick Stop cigarette permit, seconded by Travis. All ayes.
